3. Continuing Business

- a) Design Safe-CI: update on the website re-design (10') (Ellen Rathje and Hedda Prochaska)

- b) AGU Virtual Booth: on the 9/03 meeting NCO asked the Council to think about a possible NHERI participation at the virtual AGU meeting in December 2020. (5') (Dan Zehner)
Dan shared the link to a video on the current status of the virtual booth and solicited material from the NHERI components to include in it, and names to staff the booth. The NCO offered to support 5 registrants to the conference that would also agree to staff the booth. Staffing details can be discussed with Dan regarding time availability and also possible office hours. There will be two windows to provide the material. One is by November 10, and the second one is from Nov. 20 to 25, before the booth goes live on December 1.
